Apply for SNAP

The Department of Economic Security has over 60 community partners throughout Arizona who are ready and waiting to help you apply for SNAP. You can also apply for SNAP online or at a local DES eligibility office. Receiving SNAP is as easy as submitting an application, answering interview questions, providing missing documents, and, if eligible, getting your Electronic Benefits Transfer card.

You will never be charged a fee to apply for or participate in SNAP*

*Participants may be required to pay a \$5 fee when requesting excessive replacement EBT cards. Clients do not pay the fee in cash; it's deducted from the next month's allotment.
